



CATATAN WORKSHOP VERIFIED CONSERVATION AREA (VCA)

JAKARTA, 24-25 SEPTEMBER 2018

Pada tanggal 24-25 September 2018 telah dilaksanakan Workshop Verified Conservation Areas (VCA) di Hotel Santika Premiere, Jakarta. Pertemuan mencatat bahwa:

1. VCA adalah area yang dikelola berbasiskan konservasi yang telah diverifikasi oleh komite di bawah VCA.
2. Registrasi VCA merupakan suatu alat/instrument yang bersifat sukarela untuk mendorong transparansi dan akuntabilitas pengelolaan KEE.
3. Kawasan Ekosistem Esensial (KEE) guna promosi internasional dapat diregistrasi menjadi VCA.
4. Kementerian LHK akan melakukan pembelajaran terhadap 3 (tiga) lokasi/kawasan di Indonesia yang telah mendapatkan registrasi VCA.
5. KEE koridor Gajah Seblat dan KEE Mangrove Teluk Pangpang akan diregistrasi sebagai pilot project VCA.

Menindaklanjuti pertemuan ini, maka terhadap KEE yang telah ditetapkan, telah dibentuk kelembagaannya baik tunggal maupun kolaboratif, dan memiliki rencana aksi perlindungan KEE dapat diusulkan untuk registrasi VCA oleh Pemerintah Pusat dan/atau Pemerintah Daerah, kelompok masyarakat atau individu, LSM.

VERIFIED CONSERVATION AREA (VCA) WORKSHOP NOTE

JAKARTA, 24-25 SEPTEMBER 2018

A workshop on Verified Conservation Areas (VCA) took place on 24-25 September 2018 at the Hotel Santika Premiere Jakarta. The meeting noted that:

1. A VCA is an area managed for conservation that has been verified by being listed on the VCA Registry.
2. VCA registration is a tool (as voluntary) to encourage transparency and accountability for areas, such as Essential Ecosystem Area (EEA) management.
3. EEAs can be registered as VCAs for international recognition and promotion.
4. The Ministry of Environment and Forestry will learn lessons from the first three areas in Indonesia that have been listed on the VCA Registry.
5. The Seblat Elephant Corridors EEA and the Mangrove Teluk Pangpang (Pampang Bay) EEA will be registered as the pilot VCAs.

Following up on this meeting, established EEAs - that have been formed as an institution both single or collaborative and have a conservation action plan - can register as VCAs. This registration can be done by central government, and/or local governments -province or districts, NGOs, community groups, or individuals.
